A brainstorming session on the feasibility of starting NBE courses in Smaller Hospitals and Single Speciality hospitals and the requirements in terms of infrastructure and faculty thereof was held.

Initiating the discussion, Dr.Vinod Paul placed on record his appreciation at the progressive steps that have been taken by ANBAI & NBE in promoting NBE courses while maintaining quality, transparency and affordability in relation to the institutions & Students. He also had a special word of thanks for Dr.Devi Shetty's contribution towards furthering the cause of Post Graduate Medical Education in our Country.

Dr.Vinod K Paul Congratulated Dr.Abhijath Sheth, Dr.Dave, Dr.Devi and Dr.Alex for their untiring efforts in increasing the number of NBE seats and also for starting DNB Courses in the Government hospitals of Karnataka.

After extensive interaction between Dr.V.K.Paul, who joined on Skype and the participants of the brain storming session, the following suggestions were made.

The availability of over 6 lakh beds in the Private Sector, Army hospitals and the District Hospitals, which have the potential to serve as Training Centres for post graduate medical education, should be fully utilized for starting NBE courses and the following is to be carried out.

- 1. For the purpose of starting DNB courses in smaller hospitals, many such units in neighbouring areas be clubbed together for optimal utilisation of available resources.
- 2. Proper guidelines are to be created for staring DNB courses in smaller hospitals of even less than 30 bed strength.
- 3. Standard Operating Procedures are to be created for maintaining quality in teaching & evaluation.
- 4. Technology utilisation for teaching such as web based learning, webinars and other innovative methods are to be adopted.

### Suggestions offered by Dr.Devi Shetty towards promoting Post Graduate Medical Education:

- Reforms in higher education
- The methodology being adopted in the United States & United Kingdom could be studied in detail & the best practises suitable to our situation can be adopted along with redefining the requirements for a Teacher.
- The Post graduate students are to be permitted to undergo rotational training in hospitals of their choice.
- Institutions are to fulfil the required standards along with periodic evaluation and certification of teachers [with guidelines to train students], and this is to be made mandatory in order to maintain quality.

• The qualifying exit examination should be strict to the extent that only those are well trained and up to the mark will qualify.

### Responding to the above suggestions and after discussion the following was arrived upon.

- To check on the USA & UK Post Graduate medical education pattern
- > 8 years of experience following NBE degree is mandatory for teachers.
- > 3 years as senior resident post NBE degree to be considered as a specialist.
- Conceptualise criteria for teachers.
- ➤ To create network of NBE hospitals
- ➤ Rotational posting of PG students operational feasibility has to be looked into as it entails financial implications.

Dr.V.K.Paul suggested that a list of retired ex-service man Medical Teachers could be displayed on the website for information to those institutions in need of Teachers.

The possibility of engaging Part time Teachers is also to be looked into, keeping quality in mind.

Regarding Honorary Faculty the operational feasibility and its effect on quality of training is to be looked into.

Dr.Paul was of the opinion that assuring proper log maintenance by the Post graduate students, it is possible to gauge the Quality of training undergone to a certain extent.

It was suggested that NABH accredited Institutions could be accorded preference while enrolling with NBE for Post graduate courses & fellowship Courses.

It was also decided to create a Research Methodology Course which is to be offered online and is to be made compulsory for every Post graduate Students to successfully undergo the course within the first year of enrolling in Post-Graduation.

In order to effectively facilitate suggestions from faculty, website integration has been recommended.

In order to effectively liaison and carry out the academic activities of Post graduate and fellowship programmes at the NBE, it was suggested that a Post of National Dean should be created under the President for effective functioning.

#### In conclusion, the Way forward was summed up as:

- A. Creation of Teachers Accreditation Cell.
- B. Clubbing of smaller hospitals for starting DNB courses.
- C. Enabling P.G Students to undergo training at both Public & private hospitals by rotation.
- D. Possibility of utilising the Services of part time teachers & honorary faculty to be explored.
- E. Promote NBE courses in NABH accredited Institutions.
- F. The requirement of minimum number of beds to start NBE Courses in Single Speciality institutions is to be dropped.
